requirements of any and all easements and/or contractual obligations of the District now in force and effect and in such manner as to leave all sewers, appurtenances, streets, alleys, sidewalks and pavements and other structures disturbed by said work in as good condition as the same and each of them were or are prior to the commencement of said work and shall pay, indemnify and save harmless said District from any and all loss, cost, damage and/or expense which may come to the District by reason of or in any manner growing out of or connected with said work including any and all liability for and on account of any accident or accidents, injury or death, damage or damages to any person or property, caused or in any manner arising from, growing out of or connected with said work during the term of the license granted to applicant and within five years from the late of this bond and if said applicant shall in all particulars and respects carry out and fully perform each and all the covenants and agreements in said application for said license and in said Ordinance No. 406, then this obligation shall be void; otherwise to remain in full force and effect.
